Greetings What a Beautiful Cool Crispy Day..... Humidity in Low-60's.... DewPoint Mid-50'sPerfect.

******Some Guys Wanting to do a Touch-Up on Weed-Control...**

Saying stuff will be Way-to-Big--Out-of-Control by the End of Harvest

You thinking about it too...??? ... Ask Yourself these **Questions...**

1. What did we do last time ?? ... and don't use those same products again right now.

2. See whats on the Shelf in Your Spray-Shed....stuff all bought & paid for. Will it Fit right now....Da.PHI-Etc...???

And...I have had all the Guys that used it, tell me that the **WetCit** [or Vintre] makes such a huge difference in their Herbicide-Performance that they will never Spray again without it.

They use 1 Pint to 25 Ga.Water ...and ...

You should still do the 1 Pint-100 Ga.Indicate 5 if you are doing a Hi-Tec-Multi-Chemistry-Tank-Mix if using a whole bunch of Products & Nutrients

....or also if your Water is really crap-ugly-quality.... 1 Pt. Indicate 5 - 100ga.Water

One Grower I know is using this Tank-Mix below --- which I like

Per-Treated-Acre

3 Lb. Diuron80DF ... 3 Pint ParaQuat 3SL ... 1 Pint WetCit ... 4 oz. Indicate 5

You'll probably be very happy/impressed with 2 Pints-ParaQuat 3SL.... But it's cheap...and so I like the 3 Pint Rate.

******The Last 2-3 Weeks of Warm Nights** are part of the reason for increased Internal-Worm-Pressure.... Your very-thorough-Coverage is gonna make the difference in the success of your Pesticide selection.

Those rated **"E"** on C.Moth are Exirel[3Da], Imidan[7Da], Assail[7Da], Rimon[14Da], Delegate[7Da], Altacor[14Da], Belt[14Da],

VoliamFlexi[35Da], Leverage360[7Da], Turismo[14Da], Endigo[35Da], VoliamXpress[21Da].... As I have told Ya'll several times beforesome of these are just Crazy Pricey....like close to \$70-Ac.... But maybe if you've already got it on the Shelf....???
